On October 24, 2016, the Wisconsin Professional Counseling Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board issued a Final Decision and Order ("Order") limiting Respondent's professional counselor license with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent has failed to comply with all requirements for participation in drug and alcohol monitoring established by the approved drug monitoring program and is therefore in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Respondent's professional counselor license (#4222-125) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
