On January 12, 2017, the Wisconsin Board of Nursing issued a Final Decision and Order (“Order”) limiting Respondent’s professional nursing license with certain terms and conditions, including, but not limited to, completion of an AODA assessment by an approved provider. The Order further states that the Board, or its designee, may limit Respondent’s license to address concerns of the Board and address recommendations resulting from the assessment. On April 28, 2017, the Board further limited Respondent’s professional nursing license based on the recommendations from the AODA assessment. Pursuant to the Order, Respondent’s license may be suspended, without hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Respondent has failed to enroll and participate in an approved drug monitoring program and is therefore in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Respondent’s professional nursing license (#166703-30) is hereby SUSPENDED until further noticed.
2. This order is effective the date of its signing.
