On February 9, 2017 the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license and advanced practice nurse prescriber certificate. Respondent was required to complete three (3) hours of education in patient assessment and three (3) hours of education in diagnosing ischemia pursuant to the terms of the Order.
