The parties in this matter agree to the terms and conditions of the attached Stipulation as an interim order in this matter, subject to the approval of the Pharmacy Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Angela Lane, R.Ph., DOB October 9, 1978, is licensed in the state of Wisconsin to practice pharmacy, having license number 14196-40, first issued on July 14, 2004, and current through May 31, 2018. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 579 Hogan Trail, Sobieski, Wisconsin 54171-8601.

2. At all times relevant to this proceeding, Respondent was employed as a managing pharmacist in Gillett, Wisconsin.

3. The Department is investigating allegations that Respondent, while employed as a managing pharmacist, diverted large quantities of controlled substances.

4. The investigation is ongoing and incomplete. Respondent is presumed innocent of the allegations unless and until the Board issues a final decision and order finding otherwise.

5. Respondent neither admits nor denies the allegations, but consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Pharmacy Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 450.10(1), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

1. The attached Stipulation is accepted.

2. The license to practice pharmacy in the state of Wisconsin issued to Angela Lane, R.Ph., (license number 14196-40) is SUSPENDED until this matter is resolved by the Board via a formal order or non-disciplinary case closure.

3. In the event the Board resolves this case with formal discipline including suspension of Respondent's license to practice pharmacy in the state of Wisconsin, Respondent will be credited with the period of suspension Respondent serves in accordance with this Interim Order.

4. This Order is effective on the date of its signing.

Respondent Angela Lane, R.Ph., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance.
2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights, **ONLY AS TO THIS INTERIM ORDER**. Respondent retains these rights to final resolution of this matter:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Robert Ruth.
4. Respondent agrees to the adoption of the attached Interim Order by the Wisconsin Pharmacy Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Interim Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's Interim Order, if adopted in the form as attached.


5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties' agreement contemplates that if the Board, in the final disposition, suspends Respondent's license, the suspension shall be retroactive to the effective date of the Interim Order. Respondent knows, understands and agrees that if the final decision and order results in an order for a disposition other than a suspension, the suspension served under the Interim Order may have no effect.

7. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Interim Order.


8. Respondent is informed that should the Board adopt this Stipulation; the Board's Interim Order is a public record and will be published in accordance with standard Department procedure.

9. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Interim Order.


