On May 3, 2017, the Wisconsin Dentistry Examining Board (“Board”) issued a Final Decision and Order (“Order”) suspending Respondent’s dentistry license for an indefinite period. The suspension of Respondent’s license was stayed on May 18, 2017 and his license is currently limited with certain terms and conditions.

Information submitted in support of Respondent’s request for removal of the surgical extraction and root canal therapy limitations has been reviewed. Based upon the information of record, the following is entered:

ORDER

1. Respondent’s request for removal of the limitation on surgical extraction clinical procedures, as outlined in provisions 6.a.-g. of the Order, has been GRANTED.
2. Respondent’s request for removal of the limitation on root canal therapy for single-rooted teeth clinical procedures, as outlined in provisions 8.a.-g. of the Order, has been GRANTED.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
