FINDINGS OF FACT

- 1. KAYLA D SANDERS (Applicant) has filed an application to renew her Wisconsin private security person permit (#48292-108).
- 2. On or about September 13, 2013, Applicant applied for a private security permit with the Department.
- 3. At that time, information on file established that Applicant had the following violation and conviction:
 - A. On or about July 27, 2009 Operating Without a License, an ordinance violation.
 - B. On or about December 7, 2009 Disorderly Conduct, a misdemeanor.
- 4. Applicant's private security permit expired on August 31, 2014, and since that time, information on file establishes that Applicant had the following violation:
 - C. On or about February 19, 2015 Retail Theft, an ordinance violation.

CONCLUSIONS OF LAW

1. The Wisconsin Department of Safety and Professional Services has jurisdiction over this matter, pursuant to Wis. Stat. § 440.26.

2. The facts and circumstances of the conviction and violations referenced above substantially relates to the practice of a private security person. Applicant, by her conduct, is subject to action against her license, pursuant to Wis. Stat. § 440.26.

ORDER

NOW, THEREFORE, IT IS ORDERED that KAYLA D SANDERS is GRANTED a RENEWAL FOR A PRIVATE SECURITY PERMIT subject to the following LIMITATIONS, TERMS, AND CONDITIONS:

Practice Limitations

1. Applicant shall show a copy of this Order to her current and any future employer.

Applicant shall provide the Department of Safety and Professional Services Monitor
(Department Monitor) with written acknowledgement from each employer that a copy of
this Order has been received. Such acknowledgement shall be provided to the Department
Monitoring within fourteen (14) days of beginning new employment and/or within fourteen
(14) days of the date of this Order for employment current as of the date of this Order.

Reporting Requirements

- 2. It is Applicant's responsibility to arrange for her security guard supervisor(s) to provide work reports to the Department Monitor on a quarterly basis, beginning 90 days from the date of this Order. These reports shall describe the Applicant's activities and verify that she is in compliance with the laws governing the practice of a private security person and the terms of this Order.
- Applicant shall report to the Department any change of employment status, residence, address or telephone number within five (5) days of the date of a change. In addition, Applicant shall report any arrest or conviction within 48 hours of the arrest or entry of conviction.
- 4. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify the Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant.

Department Monitor

5. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

Petitions for Modification

6. Applicant may petition the Department for modification of the terms of this Order after completion of one year of practice in compliance with all terms and conditions of this Order. Applicant's petition must include her history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling one year of practice. Any such petition shall be accompanied by a written recommendation from Applicant's current employer that includes, among other things, the dates of employment and scope of responsibility during such employment, and, if applicable, her treatment provider expressly supporting the specific modifications sought. A denial of such a petition for modification shall not be deemed a denial of license under Wis. Stats. §§ 227.01(3), or 227.42, or Wis. Admin. Code § SPS 1, and shall not be subject to any right to further hearing or appeal.

Costs

Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

Suspension

8. In the event that Applicant violates any term of this Order, Applicant's license may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of the Order. The Department may, in addition and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
