

You are hereby notified that you are subject to an administrative forfeiture of \$100.00 in accordance with Wis. Stat. § 101.9209(5)(a). Any transferee of a manufactured home who fails to make application for a new certificate of title immediately upon transfer to him or her of a manufactured home may be required to forfeit not more than \$200.00.

Pursuant to Wis. Stat. § 101.02(6)(e), you have the right to petition for a hearing on the reasonableness of any order of the Department of Safety and Professional Services. Please refer to Wis. Stat. § 101.02 for further instruction on submitting such a petition. Any such petition must be sent to the Division Administrator, Division of Industry Services, P.O. Box 2658, Madison, Wisconsin 53701-2658.

You are receiving this administrative forfeiture because you failed to promptly execute the application for a new certificate of title for a manufactured home. Your actions violated Wis. Stat. § 101.9209(5)(a), and as a result, an administrative forfeiture of \$100.00 is assessed.
