You are hereby notified that you are subject to an administrative forfeiture of \$250.00 in accordance with. Wis. Stat. § 101.178(5). Any person who engages in the business of installing or servicing heating, ventilating, or air conditioning equipment without a registration from the Department of Safety and Professional Services (Department) shall be required to forfeit not less than \$50.00, and no more than \$1,000.00.

Pursuant to Wis. Stat. § 101.02(6)(e), you have the right to petition for a hearing on the reasonableness of any order of the Department of Safety and Professional Services. Please refer to Wis. Stat. § 101.02 for futher instruction on submitting such a petition. Any such petition must be sent to the Division Administrator, Division of Industry Services, P.O. Box 2658, Madison, Wisconsin 53701-2658.

You are receiving this administrative forfeiture because you attempted to pull a building permit with an invalid license number, and proceeded to work on a project without a valid HVAC contractors registration. Your actions violated Wis. Stat. § 101.178(5), and as a result, an administrative forfeiture of \$250.00 is assessed.
