You have the right to request a review of the assessment of forfeiture by sending a request to the Division Administrator, Division of Industry Services, P.O. Box 2658, Madison, Wisconsin 53701-2658, which must be received by the Division no later than 30 days from the date of mailing of this Notice. The date of mailing of this Notice is October 3, 2017. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code SPS § 305.125(6-8).

You are receiving this administrative forfeiture because you allowed Tyrone Easter to perform a cap and seal without your direct supervision at 2369 South 19th Street, Milwaukee, Wisconsin 53215. Your actions constitute a violation of Wis. Admin. Code SPS § 305.91(6)(a). The administrative forfeiture of \$1,500.00 is assessed in accordance with Wis. Admin. Code SPS § 305.125(1)(f)1.
