FINDINGS OF FACT

- I. RAQUEL HOLLINGSWORTH (Applicant) has filed an application (# 610443) for a permit to practice as a private security person in Wisconsin.
- II. Information received in the application process reflects that the Applicant has a history that includes the following violation:
 - A. On or about June 29, 1016 – Retail Theft-Intentionally Take (<=\$2,500), an ordinance violation.

CONCLUSIONS OF LAW

- I. The Wisconsin Department of Safety and Professional Services has jurisdiction over this matter, pursuant to Wis. Stat. § 440.26.
- II. The facts and circumstances of the violation referenced above substantially relate to the practice of a private security person. Applicant, by her conduct, is subject to action against her license, pursuant to Wis. Stat. §§ 111.335(1)(c)1. and 440.26 and Wis. Admin. Code chs. SPS 31 and 35.

ORDER

NOW, THEREFORE, IT IS ORDERED that RAQUEL HOLLINGSWORTH is GRANTED a PRIVATE SECURITY PERMIT subject to the following LIMITATIONS, TERMS, AND CONDITIONS:

Practice Limitations

- I. Applicant shall show a copy of this Order to her current and any future employer. Applicant shall provide the Department of Safety and Professional Services Monitor (Department Monitor) with written acknowledgement from each employer that a copy of this Order has been received. Such acknowledgement shall be provided to the Department Monitor within fourteen (14) days of beginning new employment and/or within fourteen (14) days of the date of this Order for employment current as of the date of this Order.

Reporting Requirements

- II. It is Applicant's responsibility to arrange for her security guard supervisor(s) to provide work reports to the Department Monitor on a quarterly basis, beginning 90 days from the date of this Order. These reports shall describe the Applicant's activities and verify that she is in compliance with the laws governing the practice of a private security person and the terms of this Order.
- III. Applicant shall report to the Department any change of employment status, residence, address or telephone number within five (5) days of the date of a change. In addition, Applicant shall report any arrest or conviction within 48 hours of the arrest or entry of conviction.
- IV. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify the Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant.

Department Monitor

- V. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

Petitions for Modification

- VI. Applicant may petition the Department for modification of the terms of this Order after completion of one year of practice in compliance with all terms and conditions of this Order. Applicant's petition must include the Applicant's history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling one year of practice. Any such petition shall be accompanied by a written recommendation from Applicant's current employer that includes, among other things, the dates of employment and scope of responsibility during such employment, and, if applicable, her treatment provider expressly supporting the specific modifications sought. A denial of such a petition for modification shall not be deemed a denial of license under Wis. Stat. §§ 227.01(3), or 227.42, or Wis. Admin. Code ch. SPS 1, and shall not be subject to any right to further hearing or appeal.


Costs

- VII. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

Suspension

- VIII. In the event that Applicant violates any term of this Order, Applicant's credential may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of the Order. The Department may, in addition and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.


STIPULATION
