
You are hereby notified that your Master Electrician credential is suspended for one week, beginning December 28, 2017.

The basis for this suspension is your failure to use appropriately licensed or registered individuals to install electrical wire. Specifically, you allowed Peter Tabbert, who is unlicensed, to perform electrical work under your license, at 36245 Main Street, Whitehall, Wis. 54773.

The above conduct constitutes a violation of Wis. Admin. Code § SPS 305.43(5)(b) by failing to utilize appropriately licensed or registered individuals to install electrical wiring and is subject to discipline under Wis. Admin. Code § SPS 305.10(1)(a)8.

After the one week suspension, you may request, in writing, to have your credential reinstated. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f). You have the right to request a hearing on the suspension by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wis. 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. The date of mailing of this Notice is November 28, 2017. Any hearing on the suspension will be held in accordance with the requirements stated in Wis. Stat. ch. 227.
