Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code SPS § 305.125(6-8).

David Edward was filmed, by a Fox 6 news crew, working on a section of a sump pump drain without proper licensure. Mr. Edward possesses a Journeyman Plumber – Restricted Appliance license, which does not cover such work. You are the Master Plumber who oversees David Edward. Your actions violated Wis. Admin. Code SPS § 305.91(6)(a). The administrative forfeiture of \$1500.00 is assessed in accordance with Wis. Admin. Code SPS § 305.125(1)(f)1.

You were filmed, by a Fox 6 news crew, working on a section of a sump pump drain without proper licensure. You possess a Journeyman Plumber – Restricted Appliance license, which does not cover such work. Your actions violated Wis. Stat. § 145.06(1)(a) and Wis. Admin. Code SPS §§ 305.90(1)(a) and 305.90(1)(b)3. The administrative forfeiture of \$100.00 is assessed in accordance with Wis. Admin. Code SPS § 305.125(1)(c)1.
