
You are hereby notified that your Dwelling Contractor Qualifier credential is suspended until the end of the certification term, April 10, 2018, beginning December 29, 2017.

The basis for this suspension is the dwelling you constructed at 1431 Tillberry Drive, Baraboo, Wisconsin 53913. This dwelling was not constructed in accordance with the plans submitted to the City of Baraboo or in accordance with the plans agreed to by the owner. Only one of the numerous changes was approved by the owner and none of them were approved by the municipality.

The above conduct constitutes misconduct under Wis. Admin. Code § SPS 305.10(1)(a)5. This violation is a basis for discipline pursuant to Wis. Admin. Code ch. SPS 305. After the suspension, you may request, in writing, to have your credential reinstated. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f).

You have the right to request a hearing on the suspension by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wisconsin 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. The date of mailing of this Notice is November 29, 2017. Any hearing on the suspension will be held in accordance with the requirements set forth in Wis. Stat. ch. 227.
