You are hereby notified that your Dwelling Contractor credential is suspended for seven days, beginning January 22, 2017.

The basis for this suspension is the work you performed 217 South 7<sup>th</sup> Street, Condo 6, Waterford, Wisconsin 53185. The patio door installation required a Uniform Dwelling Permit and this was not obtained, as required in Wis. Admin. Code § SPS 305.31(4)(b). An individual holding a Uniform Dwelling Qualifier credential was not associated with LJL Construction, LTD, as required in Wis. Stat. § 101.654(1)(a) and Wis. Admin. Code § SPS 305.31(1)(a).

The above conduct constitutes misconduct under Wis. Admin. Code § SPS 305.10(1)(a)5. and is a violation of state and local rules under Wis. Admin. Code § SPS 305.10(1)(a)8. This violation is a basis for discipline pursuant to Wis. Admin. Code ch. SPS 305.

After the suspension, you may request, in writing, to have your credential reinstated. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f). You have the right to request a hearing on the suspension by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wisconsin 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any hearing on the suspension will be held in accordance with the requirements set forth in Wis. Stat. ch. 227.
