

You are hereby notified that you are subject to an administrative forfeiture of \$100.00 in accordance with Wis. Admin. Code § SPS 305.125(1)(c)1. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed.

You have the right to request a review of the assessment of forfeiture by sending a request to the Division Administrator, Division of Industry Services, P.O. Box 7302, Madison, Wisconsin 53707-7302, which must be received by the Division no later than 30 days from the date of mailing of this Notice. The date of mailing of this Notice is December 22, 2017. Any review of the assessment of forfeiture will be held in accordance with the requirements set forth in Wis. Admin. Code § SPS 305.125(6-8).

You are receiving this administrative forfeiture because you installed plumbing without a license, while under the supervision of a master plumber. Specifically, the City of Janesville Plumbing Inspector Kent Larson found you installing water lines for ice machines and installing ice and drink machines. Your actions violated Wis. Stat. § 145.06(1)(a) and Wis. Admin. Code § SPS 305.90(1)(a). The administrative forfeiture of \$100.00 is assessed in accordance with Wis. Admin. Code § SPS 305.125(1)(c)1.
