On May 3, 2006, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's dentistry license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On January 30, 2018, the Dentistry Examining Board Monitoring Liaison considered Respondent's request for the return of full, unrestricted licensure. Based upon the information of record, the Board Monitoring Liaison finds and makes the following:

ORDER

1. Respondent's dentistry license (#3392-15) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
