October 23, 2012, the Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") suspending Respondent's professional counselor license for an indefinite period. The suspension shall be stayed upon Respondent petitioning the Section, and providing proof that he is in compliance with Sections C and D of the Order and that his Treater is of the opinion that Respondent is able to safely work as a professional counselor.

On January 29, 2017, the Section designee considered Respondent's request for an initial stay of suspension. Based upon the information of record, the Section designee finds and makes the following:

ORDER

1. Respondent's request for an initial stay of suspension is DENIED because he has not provided sufficient proof of compliance with Sections C and D of the Order, or proof that his Treater is of the opinion that he is able to safely work as a professional counselor.
2. This order is effective the date of its signing.
