On January 10, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On January 11, 2018, the Board considered Respondent's request for termination of direct supervision and a reduction in the frequency of drug and alcohol screens. Based upon the information of record, the Board finds and makes the following:

## <u>ORDER</u>

1. Respondent's request for termination of direct supervision is hereby GRANTED.

2. Respondent's request for a reduction in drug and alcohol screens is hereby GRANTED. Respondent's frequency is reduced to 28 urine screens and one hair test per year.

3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.

4. This order is effective the date of its signing.
