On June 13, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's professional nursing license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On November 8, 2018, the Board considered Respondent's request for a reduction in AA/NA meetings and access to controlled substances. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for reduction in AA/NA meetings is hereby GRANTED. Respondent's attendance is reduced to one meeting per week.
2. Respondent's request for access to controlled substances is hereby DENIED. Respondent needs to practice nursing under the current conditions of the Board Order before the Board will consider amending other requirements.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
