On December 8, 2016, the Wisconsin Board of Nursing (Board) issued a Final Decision and Order (FDO) suspending Respondent's professional nursing license with certain terms and conditions, including, but not limited to, completion of an assessment by an approved mental health provider experienced in evaluating health care practitioners' fitness to practice. The FDO provided for the imposition of additional limitations to address any concerns with the conduct set forth in the findings of fact and to address any recommendations resulting from the assessment.

On April 25, 2017, the Board issued an Order Imposing Additional Limitations (Order) further limiting Respondent's professional nursing license with additional limitations.

On May 10, 2018, the Board considered Respondent's request for termination of treatment. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for termination of treatment is hereby GRANTED.
2. All other terms and conditions of the FDO and Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
