#### PROCEDURAL HISTORY

On December 11, 2013, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("2013 Order") granting Applicant a limited license to practice medicine and surgery with certain terms and conditions. Per the Order, Applicant may petition the Board for removal of the limitations upon successful completion of all required educational activities and upon receipt of the statement of the educational preceptor that Applicant is capable of meeting the standard of care in independent practice.

On February 18, 2015, the Board considered Applicant's request for full, unrestricted licensure. Based upon the Order Denying Request for Full Licensure dated February 26, 2015, Applicant's request was denied for failure to comply with page 2, paragraph 2(a-d) of the Order. Applicant did not complete the CPEP post evaluation as required by the Order.

On June 17, 2015, the Board considered Applicant's second request for full, unrestricted licensure. Based upon the Order Denying Request for Full Licensure dated June 19, 2015<sup>1</sup>, Applicant's request was denied for failure to comply with page 2, paragraph 2(a-d) of the Order. Applicant did not demonstrate successful completion of all CPEP recommendations.

On October 17, 2018, the Board considered Applicant's request for consideration of his objection to the June 19, 2015 denial of full licensure. Based upon the information of record, the Board makes the following:

#### FINDINGS OF FACT

- 1. Applicant has not demonstrated successful completion of CPEP's education recommendations.
- 2. Applicant has not met regularly with the educational preceptor since on or about July 31, 2014.
- 3. The Board has not received quarterly reports from the preceptor regarding Applicant's progress since at least 2014.
  - 4. Applicant is in violation of the 2013 Order.

#### **ORDER**

- 1. Applicant Farid Aref Ahmad, M.D.'s license to practice medicine and surgery (number 61782-20) is FURTHER LIMITED as follows:
  - a. Beginning no later than November 30, 2018, Applicant may only engage in the practice of medicine and surgery as necessary to successfully complete CPEP's educational recommendations.
  - b. By no later than November 30, 2018, Applicant shall provide an attestation to the Department Monitor that he has ceased the independent practice of medicine and surgery and understands he may only engage in the practice of medicine and surgery as necessary to successfully complete CPEP's educational recommendations.
  - c. Beginning 90 days after the date of this Order, and every 90 days thereafter, Applicant shall provide an attestation that he is in compliance with the terms of this Order to the Department Monitor.
  - d. Applicant shall provide CPEP with authorization(s) for release of information allowing the Board, its designee, and any employee of the Division of Legal Services and Compliance to obtain and discuss any information relevant to Applicant's compliance with the CPEP program throughout the pendency of this Order. Copies of these releases shall be immediately filed with the Department Monitor.
  - e. Any petition for removal of this limitation must be accompanied by satisfactory evidence of successful completion of all CPEP educational recommendations.
- 2. Any attestations, releases, petitions, or other information required by this Order may be mailed, faxed, or emailed to:

In the event Applicant violates any term of the Order, Applicant's license (number 61782-20), or Applicant's right to renew his license, may, in the discretion of the Board or its designee, be SUSPENDED without further notice or hearing, until Applicant has complied with the terms of the Order. The Board may, in additional and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.
  - 4. This order is effective the date of its signing.
