On December 4, 2014, the Wisconsin Real Estate Examining Board issued a Final Decision and Order ("Order") requiring Respondent Palermo to successfully complete an education course on the topic of "trust accounts," pay a \$500.00 forfeiture, and pay \$515.00 in costs of the proceeding within ninety (90) days. On September 14, 2018, Respondent Palermo's real estate broker license was suspended for failure to complete the education and pay the costs of the proceeding as ordered.

Based upon the information of record, which includes proof that Respondent Palermo has now completed the education and submitted the payment for costs in full, the following is entered:

ORDER

- 1. The suspension is terminated and Respondent Palermo's real estate broker license (#55840-90) is hereby returned to full, unrestricted status.
- 2. All limitations and encumbrances upon Respondent Palermo's credential are removed.
 - 3. This order is effective the date of its signing.
