On March 12, 2015, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") suspending Respondent's practical nursing license for an indefinite period. Respondent may petition for a stay of suspension upon providing proof sufficient to the Board or it's designee that Respondent has in compliance with sections C and D of the Order for the most consecutive three months.

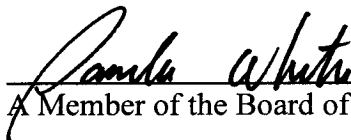

ORDER
