On March 18, 2015, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$550.00 in costs of the proceeding according to a payment plan, and complete three (3) hours of education on the topic of "time management" and three (3) hours on "child welfare and safety" within 90 days.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the education requirements. Therefore, the following is entered:

ORDER

1. Respondent's advanced practice social worker certificate (#128710-121) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full and has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
