On July 20, 2015, the Wisconsin Physical Therapy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's five (5) year right to renew for an indefinite period. After 180 days, Respondent may petition for a stay of suspension on his right to renew upon Respondent having provided proof, which was determined by the Board or its designee to be sufficient, that Respondent is in compliance with the provision of Section C and D of the Order.

Respondent's petition for a stay of suspension on his five (5) year right to renew has been reviewed pursuant to the Order. Based upon the information of record, the following is entered:

ORDER

1. The suspension of Respondent's five (5) year right to renew (#9916-24) is hereby STAYED.
2. The stay is continuous, contingent upon Respondent's compliance with the terms and conditions of the Order.
3. This order is effective the date of its signing.
