On August 20, 2015, the Wisconsin Board of Nursing ("Board") issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nursing license with certain terms and conditions.

ORDER

4. Applicant's request for reduction in screens is hereby DENIED.
