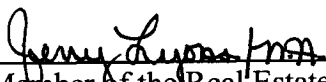
On November 9, 2015, the Wisconsin Real Estate Examining Board issued an Order Granting Limited Certificate of Registration ("Order"), which granted Applicant a limited real estate salesperson license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without further notice or hearing, for substantial or repeated violation of any provision.

Information has been received that demonstrates Applicant has been working as a real estate salesperson without a Wisconsin licensed broker approved by the Board. Applicant also has not been submitting quarterly reports and is therefore in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Applicant's real estate salesperson license (#81149-94) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
