On January 27, 2016, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") issued a Final Decision and Order ("2016 Order") limiting Respondent's clinical social work license with certain terms and conditions. On February 9, 2018, upon completion of the evaluation required by the 2016 Order, the Section issued an order imposing additional limitations on Respondent's license ("2018 Order"). Pursuant to the 2018 Order, Respondent's license may be suspended, without hearing, for violation of any provision.

Information has been received that demonstrates Respondent has failed to obtain pre-approval for her work site, supervisor, mentor, and required education courses. Respondent also failed to submit quarterly psychiatric and therapeutic treatment reports and therefore is in violation of the terms of the Order. As a result, the following is entered:

ORDER

1. Respondent's clinical social work license (#7111-123) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
