On January 27, 2016, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") issued a Final Decision and Order ("2016 Order") limiting Respondent's clinical social work license with certain terms and conditions. On February 9, 2018, upon completion of the evaluation required by the 2016 Order, the Section issued an order imposing additional limitations on Respondent's license ("2018 Order").

On July 24, 2018, Respondent's clinical social work license was suspended for violation of the terms of the 2018 Order. Respondent may petition the Section or its designee for termination of the suspension upon demonstrating compliance with the 2018 Order.

Based upon the information of record, which includes proof that Respondent is in compliance with the professional mentor, education, and treatment requirements of the 2018 Order, the following is entered:

ORDER

1. Respondent's request for termination of the suspension is hereby GRANTED.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
