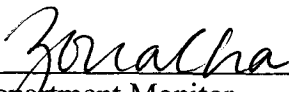
Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

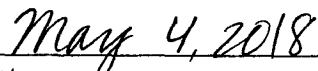
1. Respondent's license to practice medicine and surgery (#19558-20) is returned to full, unrestricted status.
