On July 19, 2016, the Wisconsin Massage Therapy and Bodywork Therapy Affiliated Credentialing Board issued a Final Decision and Order ("Order") requiring Respondent to complete ten (10) hours of education on the topic of "professional ethics" within six (6) months of the date of the Order. On October 20, 2017, Respondent's massage therapy and bodywork therapy license was suspended for failure to complete the education as ordered.
