On October 24, 2016, the Wisconsin Professional Counselor Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board issued a Final Decision and Order ("Order") limiting Respondent's professional counselor license with certain terms and conditions. On September 22, 2017, Respondent's license was suspended for violation of the Order when he failed to comply with all requirements for participation in drug and alcohol monitoring established by the approved drug monitoring program.

Based upon the information of record, which includes proof that Respondent is now in compliance with the terms and conditions of the Order, the following is entered:

ORDER

1. The suspension of Respondent's professional counselor license (#4222-125) is hereby terminated.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
