On August 16, 2017, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery for seven (7) consecutive days, and limiting it with certain terms and conditions.

On January 2, 2018, the Board designee considered Respondent's request to terminate the requirement that Respondent engage the services of a licensed psychiatrist. Based upon the information of record, including a recommendation from Respondent's Treater, the following is entered:

ORDER

1. Respondent's request for termination of the requirement that he engage the services of a licensed psychiatrist is GRANTED.
2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
3. This order is effective the date of its signing.
