On September 14, 2017, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license with certain terms and conditions including, but not limited to, completion of an alcohol and other drug abuse (AODA) assessment by an approved evaluator. The Board may impose additional limitations upon Respondent's license based on the results of the assessment and the AODA evaluator's recommendations.

On January 11, 2018, the Board reviewed and accepted the report resulting from Respondent's AODA assessment. Based on the results of the assessment and the evaluator's recommendations, the following is entered:

ORDER

1. Respondent's professional nursing license (#140355-30) is further LIMITED as follows:
 - a. Respondent shall abstain from all personal use of alcohol.
 - b. Within 30 days from the date of this order, Respondent shall provide proof to the Department Monitor that she has begun or continued treatment with a Board approved treater whose credential is in good standing. Respondent shall immediately provide the treater with a copy of this Order, a copy of the Psychotherapy Intake Note dated November 17, 2017, and a release authorizing the treater to discuss the progress of Respondent's treatment with the Board, its designee and the Department Monitor.
 - i. The treater shall be pre-approved by the Board or its designee. The treater must be a Wisconsin licensed professional, with an unencumbered license, and who is experienced in utilizing the treatment modalities recommended by the ADOA evaluator.
 - ii. The frequency of sessions shall be determined by the Board approved treater, and shall continue for a period of at least six (6) months.

iii. Treatment shall include a focus on supportive therapy, normalization, cognitive behavioral therapy (CBT), mindfulness, and acceptance and commitment (ACT) therapy. Other modalities may be used in the future as appropriate and determined by the treater.

iv. The treater shall submit quarterly reports as directed by the Department Monitor. It is Respondent's responsibility to ensure the reports are submitted when due. The treater shall immediately report any unprofessional conduct or suspected violation of this order.

c. Respondent shall follow all recommendations for treatment set forth by the AODA evaluator and Respondent's treater.
