On January 3, 2018, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's dentistry license. Respondent was required to complete twelve (12) hours of education in "diagnosing with cone beam scan" and complete four (4) hours of education in "treatment planning difficult implant cases" pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

2. All limitations and encumbrances upon Respondent's credential are removed.
