You are hereby notified that your Dwelling Contractor Qualifier certification is suspended for one week, beginning February 26, 2018.

This suspension is based upon a permit from the Village of Sussex (# 15-0184), and a permit from the Town of Erin (# 15-32B), that you pulled between June 16, 2014, and December 18, 2015, while your company's Dwelling Contractor certification was expired.

The above conduct constitutes a violation of both Wis. Stat. § 101.654(1)(a) and Wis. Admin. Code § SPS 305.31(1)(a)(1 & 2). This violation is a basis for discipline pursuant to Wis. Admin. Code ch. SPS 305.

After the one week suspension, you may request, in writing, to have your credential reinstated. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f). You have the right to request a hearing on the suspension by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wisconsin 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any hearing on the suspension will be held in accordance with the requirements set forth in Wis. Stat. ch. 227.
