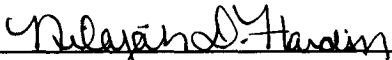
On February 2, 2018, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's real estate broker license. Respondent was required to complete an education course on the topic of "business ethics," pursuant to the terms of the Order.
