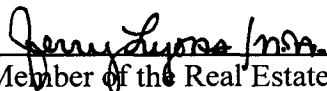
On February 16, 2018, the Wisconsin Real Estate Examining Board ("Board") granted Applicant a limited real estate broker license in the state of Wisconsin.
