The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Dentistry Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Andy Mancini, D.D.S., DOB February 10, 1976, is licensed to practice dentistry in the state of Wisconsin, having license number 6499-15, first issued on May 17, 2010, and current through September 30, 2019. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 131 Carmichael Road, Suite 200, Hudson, Wisconsin 54016.

2. At all times relevant to this proceeding, Respondent owned, and was employed as a dentist as a solo practitioner, at a pediatric dental clinic located in Hudson, Wisconsin.

3. Between November 5, 2015, and May 16, 2016, the Division of Legal Services and Compliance (DLSC) received complaints regarding the Respondent's dental practice.

4. These matters have not been litigated and as such remain unproven. Respondent denies the allegations and there is no admission of wrong-doing.

5. For reasons unrelated to this matter, Respondent has elected to retire from the practice of dentistry in the state of Wisconsin.

6. Respondent consents to the entry of the following Conclusions of Law and Order.

#### CONCLUSIONS OF LAW

1. The Wisconsin Dentistry Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 447.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

#### ORDER

1. The attached Stipulation is accepted.

2. The Board accepts the permanent SURRENDER of the license to practice dentistry in the state of Wisconsin, license number 6499-15, issued to Respondent Andy Mancini, D.D.S., effective June 1, 2018.

3. Respondent is on notice that effective as of June 1, 2018, he may not engage in the practice of dentistry in the state of Wisconsin, nor may he hold himself out as one so licensed or otherwise authorized to practice dentistry in this state.

4. This SURRENDER constitutes Respondent's permanent relinquishment of his license to practice dentistry in the state of Wisconsin.

5. The Respondent is not responsible for any costs, fees, penalties or forfeitures of any kind. associated with this matter.


6. Respondent shall immediately return all indicia of Wisconsin licensure to the Department Monitor at the address below:

STIPULATION

Division of Legal Services and Compliance Case Nos. 15 DEN 087, 16 DEN 002,  
and 16 DEN 041

Respondent Andy Mancini, D.D.S., and the Division of Legal Services and Compliance,  
Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the  
Division of Legal Services and Compliance. Respondent consents to the resolution of this  
investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily  
and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has  
the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by  
subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral  
arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution,  
the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code,  
and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has  
been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent  
is represented by Ryan Cari.


4. Respondent agrees to the adoption of the attached Final Decision and Order by  
the Wisconsin Dentistry Examining Board (Board). The parties to the Stipulation consent to the  
entry of the attached Final Decision and Order without further notice, pleading, appearance or  
consent of the parties. Respondent waives all rights to any appeal of the Board's order, if  
adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent or Respondent's attorney, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.


