You are hereby notified that your Dwelling Contractor Qualifier certification is suspended for sixty (60) days, beginning April 23, 2018.

The basis for this suspension is your conviction in Brown County Circuit Court Case Number 2015CF001419. In that case, you were found guilty of two felony counts of Theft by Contractor.

The above conviction is substantially related to your Dwelling Contractor Qualifier certification, and thus, constitutes a violation under Wis. Admin. Code § SPS 305.10(1)(a)6. The above conviction also constitutes misconduct under Wis. Admin. Code § SPS 305.10(1)(a)5. Misconduct includes financial misconduct under Wis. Admin. Code § SPS 305.003(43). This violation is a basis for discipline pursuant to Wis. Admin. Code ch. SPS 305.

After the sixty (60) day suspension, you may request, in writing, to have your credential reinstated. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f). You have the right to request a hearing on the suspension by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wisconsin 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any hearing on the suspension will be held in accordance with the requirements set forth in Wis. Stat. ch. 227.
