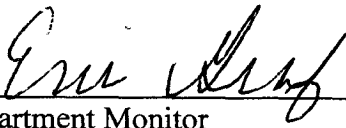
On May 10, 2018, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license. Respondent was required to complete 4 hours of education in nursing scope of practice and 3 hours in critical thinking pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's professional nursing license (#85799-30) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
