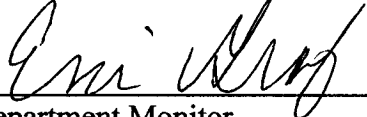
On July 10, 2018, the Wisconsin Board of Nursing issued an Order Granting Limited License ("Order"), which granted Applicant a limited professional nursing license with certain terms and conditions. Pursuant to the Order, Applicant's license may be suspended, without further notice or hearing, upon receipt of information that Applicant is in violation of any provision of this Order.

Information has been received that demonstrates Applicant has ceased participation in an approved drug and alcohol monitoring program and therefore is in violation of the terms of the Order. As a result, the following is entered:

1. Applicant's professional nursing license (#112605-30) is hereby SUSPENDED until further notice.
