You are hereby notified that your Soil Tester certification is suspended for seven days, beginning on September 10, 2018.

The basis for this suspension is the soil evaluation report you submitted to Peirce County, for 12348 884<sup>th</sup> Avenue River Falls, WI 54022. The soil evaluation report is signed by you, as the certified soil tester. The printed portion of the soil evaluation report is identical to a report prepared by Edwin Taylor. You admitted to not performing this soil test, copying the report prepared by Edwin Taylor, and signing your name to it.

The above conduct constitutes misconduct under Wis. Admin. Code § SPS 305.10(1)(a)5. This violation is a basis for discipline pursuant to Wis. Admin. Code ch. SPS 305. After the suspension, you may request, in writing, to have your credential reinstated. The reinstatement process is set forth in Wis. Admin. Code § SPS 305.10(1)(f).

You have the right to request a hearing on the suspension by sending a request for hearing to the Department of Safety and Professional Services, Chief Legal Counsel, P.O. Box 8368, Madison, Wisconsin 53708-8368, which must be received by the Department no later than 30 days from the date of mailing of this Notice. Any hearing on the suspension will be held in accordance with the requirements set forth in Wis. Stat. ch. 227.
