FINDINGS OF FACT

1. Andrea Meleski (Applicant) has filed an application (#633121) for a chiropractic technician certificate.
2. Information received in the application process reflects that Applicant has the following convictions and violations:
 - a. On or about December 4, 2009, Applicant was convicted of Possession of Paraphernalia, an ordinance violation.
 - b. On or about February 14, 2010, Applicant was convicted of Operating While Intoxicated (1st), an ordinance violation.
 - c. On or about August 25, 2010, Applicant was convicted of Underage-Possess/Consume Alcohol, an ordinance violation.
 - d. On or about July 12, 2018, Applicant was convicted of Issue of Worthless Checks (<=\$2500) (two counts), a misdemeanor.
3. Information received in the application process reflects that Applicant has a recent drug or alcohol addiction issue.

CONCLUSIONS OF LAW

1. The Wisconsin Chiropractic Examining Board (Board) has jurisdiction over this matter pursuant to Wis. Stat. § 446.026 and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. §§ 15.08(5)(c) and 227.44(5).
2. Applicant, by her conduct, is subject to limitations against her certificate pursuant to Wis. Stat. § 446.03(2).
3. Limitations upon Applicant's certificate are necessary to ensure that she is competent to act in a manner which safeguards the interests of the public.

ORDER

NOW, THEREFORE, IT IS ORDERED that ANDREA MELESKI is GRANTED A CHIROPRACTIC TECHNICIAN CERTIFICATION subject to the following LIMITATIONS, TERMS AND CONDITIONS:

Practice Limitations

1. Applicant shall at all times work under the direct supervision of a Board-approved, Wisconsin licensed chiropractor, who has received a copy of this Order.
2. Prior to commencing practice, Applicant shall provide a copy of this Order and all other subsequent orders immediately to supervisory personnel at all settings where Applicant works as a chiropractic technician, currently or in the future.
3. Applicant shall commit no new violations of law and shall report all law enforcement contacts leading to conviction to the Department Monitor within 48 hours of any such event.
4. Applicant shall comply with all sentencing requirement(s) imposed upon her by the court in Waukesha County Circuit Court Case No. 2017CF001197 and shall immediately notify the Department Monitor of any violation(s) of such sentencing requirement(s).
5. Upon successful completion of all sentencing requirement(s), Applicant shall immediately provide to the Department Monitor acceptable documentation from the court of Applicant's successful completion of all sentencing requirement(s) in Waukesha County Circuit Court Case No. 2017CF001197.
6. Applicant shall continue to attend 12-step meetings for one year, at the frequency of at least twice every month. Applicant shall obtain proof of attendance at such meetings and submit such proof quarterly to the Department Monitor.
7. Applicant shall report to the Board any change of employment status, residence, address or telephone number within five (5) days of the date of a change.

9. Applicant is responsible for compliance with all of the terms and conditions of this Order. Applicant shall promptly notify the Department Monitor of any violations of any of the terms and conditions of this Order by Applicant.

10. Applicant may petition the Board after one year for modification of the terms of this Order. Applicant's petition must include Applicant's history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling one year of practice. Any such petition shall be accompanied by a written recommendation from Applicant's current employer that includes, among other things, the dates of employment and scope of responsibility during such employment. Denial of a petition in whole or in part shall not be considered a denial of certificate within the meaning of Wis. Stat. § 227.01(3)(a), and Applicant shall not have a right to any further hearings or proceedings on the denial.

11. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

12. In the event that the Applicant violates any term of this Order, Applicant's certificate may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Applicant has provided proof, which is determined by the Board or its designee to be sufficient, that Applicant is in compliance with the terms of the Order. The Board may, in addition and/or in the alternative, refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

13. This Order is effective on the date of its signing.

It is stipulated between the Applicant and the Wisconsin Chiropractic Examining Board (Board) as follows:

1. The Applicant has filed an application for a chiropractic technician certificate.
2. Based upon the information of record, the Board agrees to issue, and the Applicant agrees to accept, an Order granting a chiropractic technician certificate, subject to the terms and conditions set forth in the attached Order adopting the Stipulation.
3. Applicant understands that by signing this Stipulation, Applicant voluntarily and knowingly waives the following rights:
 - the right to request a hearing related to the denial of the application;
 - the right to confront and cross-examine the witnesses against Applicant;
 - the right to call witnesses on Applicant's behalf and to compel their attendance by subpoena;
 - the right to testify on Applicant's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to the Applicant under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
4. Applicant is aware of Applicant's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
5. Applicant agrees to the adoption of the attached Order Granting Limited Certificate by the Board. The parties to the Stipulation consent to the entry of the attached Order Granting Limited Certificate without further notice, appearance, or consent of the parties.
6. Applicant waives all rights to any appeal of the Board's Order, if adopted in the form as attached.

7. Applicant is informed that the Order Granting Limited Certificate is a public record and will be published in accordance with standard procedure.
