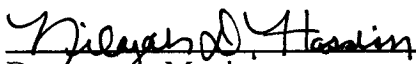

On September 6, 2018, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board ("Section") granted Applicant a limited social worker training certificate in the state of Wisconsin. Pursuant to the Order Granting Limited Training Certificate ("Order") issued on the same date, Applicant may be suspended for violation of any provision. The information of record demonstrates that Applicant has failed to enroll in an Approved Program and as a result the following is entered:

ORDER

2. Applicant may petition the Section or its designee for termination of the suspension upon demonstrating continuous compliance with the terms and conditions of the Order for at least the most recent three (3) consecutive months.
