The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Amanda S. Addison, R.N., A.P.N.P., (DOB: August 18, 1982) is licensed in the State of Wisconsin as a professional nurse, having license number 156419-30, first issued on September 22, 2006, and current through February 28, 2020. Respondent is certified in the State of Wisconsin as an advanced practice nurse prescriber, having certificate number 5675-33, first issued on February 11, 2014, and current through September 30, 2018.

2. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 10043 County Road K, Lancaster, Wisconsin 53813.

3. At all times relevant to this proceeding, Respondent was employed as an advanced practice nurse prescriber at a health center (Facility), located in Dubuque, Iowa.

4. On September 8, 2016, Respondent's license and certificate were suspended by the Board and her privilege to practice was limited to require an alcohol and other drug abuse (A.O.D.A.) assessment and compliance with the treater's recommendations.

5. On December 28, 2016, the Board lifted the suspension but retained the requirement Respondent comply with A.O.D.A. recommendations made during Respondent's A.O.D.A. assessment.

6. On June 9, 2017, Respondent left a voicemail at Pharmacy A, a pharmacy in Wisconsin, for two (2) prescriptions for Patient X. One prescription was for prednisone and the other prescription was for generic Bactrim®.

7. Pharmacist C, who worked at Pharmacy A, researched Respondent's Wisconsin license and Drug Enforcement Agency (D.E.A.) registration number and found the Wisconsin license to be valid with restrictions. These prescriptions were dispensed.

8. On August 1, 2017, Pharmacy A received a fax indicating that Patient X wanted a prescription for zolpidem, prescribed by Respondent, transferred to Pharmacy A from Pharmacy B. Pharmacist C called Pharmacy B and spoke with another pharmacist who expressed concern about the relationship between Respondent and Patient X.

9. Pharmacist C recognized Respondent as prescriber and again researched Respondent's license. Pharmacist C discovered the license still valid with restrictions but the D.E.A. number on file was invalid. Pharmacist C told Patient X the prescription could not be filled because the D.E.A. number was inactive.

10. On August 2, 2017, Respondent left a voicemail for Pharmacy A with a new D.E.A. number. This number was issued on April 26, 2017.

11. Pharmacist C called Respondent's employer and spoke with a nurse practitioner who agreed to discuss the situation with Respondent's collaborating physician. The collaborating physician cancelled the prescription for zolpidem.

12. Patient X was not a patient of the Facility where Respondent was employed on August 1, 2017.

13. Respondent stated that Patient X was a patient at her previous employer, Facility Y. Facility Y did not have any patient records for Patient X.

14. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing has jurisdiction to act in this matter pursuant to Wis. Stat. § 441.07, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. By the conduct described in the Findings of Fact, Amanda S. Addison, R.N., A.P.N.P., violated Wis. Admin. Code § N 7.03(6)(c), by departing from or failing to conform to the minimal standards of acceptable nursing practice that may create unnecessary risk or danger to a patient's life, health, or safety.

3. By the conduct described in the Findings of Fact, Amanda S. Addison, R.N., A.P.N.P., violated Wis. Admin. Code § N 7.03(8)(a), by prescribing of any drug other than in the course of legitimate practice or as otherwise prohibited by law.

3. As a result of the above conduct, Amanda S. Addison, R.N., A.P.N.P., is subject to discipline pursuant to Wis. Stat. § 441.07(1g)(b) and (d).

ORDER

1. The attached Stipulation is accepted.

2. Respondent Amanda S. Addison, R.N., A.P.N.P., is REPRIMANDED.

3. The professional nurse and advanced practice nurse prescriber license issued to Amanda S. Addison, R.N., A.P.N.P. (license number 156419-30 and certificate number 5675-33) and her privilege to practice in Wisconsin pursuant to the Nurse Licensure Compact and the enhanced Nurse Licensure Compact, are LIMITED as follows:

- a. Within ninety (90) days of the date of this Order, Respondent shall at her own expense, successfully complete three (3) hours of education on the topic of professional boundaries, three (3) hours of education on the topic of appropriate prescribing of controlled substances, and five (5) hours of education on the topic of professional accountability and legal liability offered by a provider pre-approved by the Board's monitoring liaison, including taking and passing any exam offered for the courses.
- b. Respondent shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any continuing education requirements that have been or may be instituted by the Board or Department, and also may not be used in future attempts to upgrade a credential in Wisconsin.
- c. This limitation shall be removed from Respondent's license after satisfying the Board or its designee that Respondent has successfully completed all of the ordered education.

4. Pursuant to Nurse Licensure Compact and enhanced Nurse Licensure Compact regulations, Respondent's nursing practice is limited to Wisconsin during the pendency of this limitation. This requirement may be waived only upon the prior written authorization of both the Wisconsin Board of Nursing and the regulatory board in the state in which Respondent proposes to practice.

5. Within 120 days from the date of this Order, Amanda S. Addison, R.N., A.P.N.P., shall pay COSTS of this matter in the amount of \$595.00.

6. Request for approval of courses, proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

7. In the event Respondent violates any term of this Order, Respondent's license and certificate (license no. 156419-30 and certificate no. 5675-33), or Respondent's right to renew her license and/or certificate, may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of the Order. The Board may, in addition and/or in the alternative refer any violation of this Order to the Division of Legal Services and Compliance for further investigation and action.

8. This Order is effective on the date of its signing.

STIPULATION

Respondent Amanda S. Addison, R.N., A.P.N.P., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

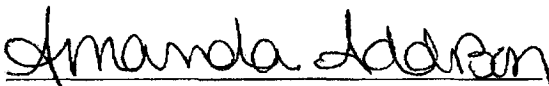
5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
