You are hereby notified that your request for a review of an assessment has been reviewed by an administrator. The administrator has determined that you have provided sufficient reasons for a review and therefore your request is granted.

The review shall be administered according to Wis. Admin. Code § SPS 305.125(6)(c). The review shall take place at the Hill Farms State Office Building, 4822 Madison Yards Way, Madison, WI 53705 on October 15, 2018, in Room N103 at 10:00 a.m., in front of Division Administrator Christopher Joch. During the review you shall be provided an opportunity to present statements and documents regarding the contested notice of administrative forfeiture and the grounds for the assessment. The department shall be represented to provide technical expertise during this review as allowed by Wis. Admin. Code § SPS 305.125(6)(c)7.

Once the review is completed the administrator shall issue a written decision within 30 days following a review. The written decision shall include information about appeal rights and procedures if the decision is to deny overturning the assessment of administrative forfeiture and the grounds for assessment. Wis. Admin. Code § SPS 305.125(7).
