

You are hereby notified that your request for a review of an assessment of forfeiture is hereby denied. Christopher Joch, Division Administrator, reviewed your request and denies a hearing opportunity on the basis that your appeal admits to the offense. It being your first offense and other individuals receiving a lesser fine is irrelevant. The Wisconsin Administrative Code is set forth by the legislature and the fine amount is not discretionary. Since you admitted to the violation you are subject to an administrative forfeiture of \$1,500.00 in accordance with Wis. Admin. Code § SPS 305.125(1)(f)1. This forfeiture must be paid within 30 days of the date of mailing of this Notice, or a 12% interest penalty will be assessed and/or collections actions may be taken.

You have the right to request a review of this denial by an Administrator by sending a request in writing to the Secretary of the Department of Safety and Professional Services, Laura Gutierrez. All requests shall be sent to Al Rohmeyer, Chief Legal Counsel, P.O. Box 8368 4822 Madison Yards Way, Madison, WI 53708-8368. A request for a hearing shall include a statement of the specific reasons why you believe the forfeiture assessment and the grounds for assessment should be overturned. The request must be received no later than 30 days from the date of mailing of this Notice. This shall be a contested hearing and shall be governed by the provisions under Wisconsin Statutes Chapter 227. *See* Wis. Admin. Code § SPS 305.125(8).
