#### **INVESTIGATION NOTES:**

This DEPARTMENT ORDER is issued as a result of an inspection on the above referenced site (17 COM 029).

The following violations were revealed:

Wis. Admin. Code § SPS 376.12(1) Floor loads. (1) Floors shall not be loaded beyond the safe load which corresponds to the unit stresses specified in ss. Ind. 53.07, 53.22, 53.24, and 53.28, 1956.

Suggested Action: Provide structural information for the repair and replacement of floor area. Repair or replace floor to meet structural loads.

Wis. Admin. Code § SPS 376.07 Passageways. Every public passage way or aisle leading to or from a stairway, fire escape, or exit door shall be kept clear and unobstructed at all times. Where loose chairs or seats would be liable to cause confusion or obstruction, such chairs or seats must be fastened.

Suggested Action: Move the water heater that is obstructing the rear exit door.

You are hereby ordered to have the installation corrected to conform to the indicated provisions of the Wisconsin Administrative Code and/or Wisconsin Statutes. This installation shall be corrected by the compliance date noted, and upon correction of violations I must be notified. If you fail to comply, this order is enforceable in circuit court pursuant to s. 101.02(13), Stats., with forfeitures ranging from \$10 to \$100 per day for each violation.

Wis. Admin. Code § SPS 303.03 Permits any person affected by a rule of the department to petition for a variance of the rule. The petition needs to establish equivalency to the rule, be provided on the form from the department and be submitted with accompanying fee and municipal recommendation.

Wis. Stat. § 101.02(6)(e). Any employer or other person interested either because of ownership in or occupation of any property affected by any such order, or otherwise, may petition for a hearing on the reasonableness of any order of the department in the manner provided in this subchapter. Petitions must be received within 30 days of the date of this order.
