INVESTIGATION NOTES:

This DEPARTMENT ORDER is issued as a result of an inspection on the above referenced site.

The following violations were revealed:

1. Code Section Violated: 1910.1001(j)(7)(iv) The employer shall also provide, at no cost to employees who perform housekeeping operations in an area which contains ACM or PACM, an asbestos awareness training course, which shall at a minimum contain the following elements: health effects of asbestos, locations of ACM and PACM in the building/facility, recognition of ACM or PACM damage and deterioration, requirements in this standard relating to housekeeping, and proper response to fiber release episodes, to all employees who perform housekeeping work in area where ACM and/or PACM is present. Each such employee shall be so trained at least once per year.

Condition Found: Annual training records were not available for review.

Action Required: Provide annual training to custodial and maintenance personnel.

2. Orders were entered on December 2, 2014, (Trans. ID#2463679) (attached as Ex. 1) requiring providing annual training to custodial and maintenance personnel staff and to develop a communication method to inform contractors of the presence and location of PACM and ACM in the buildings. An investigation determined that proper training was not provided in 2016 and 2017. Therefore, due to this violation of the 2014 orders the Department requires the following for the next five years (2019-2023):

Provide annual records that custodial and maintenance staff have received the more in-depth asbestos training as required by 29 CFR §1910.1001(j)(7)(iv) to Ann Jurkowski (Ann. Jurkowski @wisconsin.gov) or another DSPS Industrial Hygienist before December 31 of each year.

All violations starting with "1910" are incorporated through SPS 332.50(2).

If you fail to comply, this order is enforceable in circuit court pursuant to Wis. Stat. § 101.02(13), Stats., with forfeitures ranging from \$10 to \$100 per day for each violation

Wis. Stat. § 101.02(6)(e) stats. Any employer or other person interested either because of ownership in or occupation of any property affected by any such order, or otherwise, may petition for a hearing on the reasonableness of any order of the department in the manner provided in this subchapter. The petition shall set out specifically and in full detail the order upon which a hearing is desired and every reason why such order is unreasonable, and every issue to be considered by the department on the hearing. The petitioner shall be deemed to have finally waived all objections to any irregularities and illegalities in the order upon which a hearing is sought other than those set forth in the petition. All petitions must be received within 30 days of this Order.

Wis. Admin. Code § SPS 303.03 Permits any person affected by a rule of the department to petition for a variance of the rule. The petition needs to establish equivalency to the rule, be provided on the form from the department and be submitted with accompanying fee and municipal recommendation.

The following violations were revealed:

ASBESTOS

1.Code Section Violated: 1910.1001(j)(3)(i) Building and facility owners shall determine the presence, location, and quantity of ACM and/or PACM at the work site. Employers and building and facility owners shall exercise due diligence in complying with these requirements to inform employers and employees about the presence and location of ACM and PACM.

Condition Found: PACM floor tile was removed by a contractor.

Action Required: Develop a communication method to inform contractors of the presence and locations of PACM and "ACM in buildings."

2.Code Section Violated: 1910.1001(j)(7)(iv) The employer shall also provide, at no cost to employees who perform housekeeping operations in an area which contains ACM or PACM, an asbestos awareness training course, which shall at a minimum contain the following elements: health effects of asbestos, locations of ACM and PACM in the building/facility, recognition of ACM or PACM damage and deterioration, requirements in this standard relating to housekeeping, and proper response to fiber release episodes, to all employees who perform housekeeping work in area where ACM and/or PACM is present. Each such employee shall be so trained at least once per year.
